# 2024 MAY MANIA: SHOP, SPIN AND WIN PROMOTION

# **Terms and Conditions**

- 1. These terms and conditions are for all entrants who enter the '2024 May Mania: Shop, Spin and Win Promotion'. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
  - 2. The "Promoter" is Casuarina Investment Fund Pty Ltd ABN 28 815 802 041, 247 Trower Road, Casuarina NT 0810. Telephone number (08) 8920 2300. The shopping centre owners, managers and all employees of all stores are ineligible to enter.

## **ELIGIBILITY**

This Promotion is open to Casuarina Square customers residing in Australia who are 18 years of age and over. The following persons are ineligible for the Promotion: (i) directors and employees of the Promoter, its related companies or any of its agencies or retailers that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling of an aforementioned excluded person; and (iii) any person whom the Promoter has previously notified is not permitted to enter the Promoter's promotions.

### PROMOTION PERIOD

The Promotion commences at 09:00am Australian Central Standard ("ACST") Monday, 13 May and closes at 1:00pm (ACST), Sunday, 26 May 2024. ("Promotion Period").

# **HOW TO ENTER**

To enter this Promotion, eligible individuals must:

- 2. Spend \$100 or more at Casuarina Square retailers, excluding major retailers (Coles, Woolworths, Big W, JB Hi-Fi and BCC Cinemas), during the promotion period\* for your chance to win a share of \$7,500. Multiple receipts over the promotional period are accepted. Receipt values must be equivalent to \$100 or more.
- 3. Fill in the 2024 Shop, Spin & Win form and upload your receipts. Must be the original store receipt. Copies and Eftpos terminal receipts are not accepted. Entries cannot be combined e.g. if one entry is valued at \$150 and the second form is valued at \$150, it's one spin for the first entry and one spin for a second entry form, totalling 2 spins.
- 4. Visit the Resort Node between 10 am 2 pm from Friday, 24 May to Sunday, 26 May, located behind The Coffee Club near Michael Hill (refer to prizes in terms and conditions).
- 5. Present your valid online entry form along with receipts to the Casuarina Square team member to receive a chance to spin the wheel. One spin per valid entry.
- 6. See the spinning wheel operator to redeem the prize.

It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoter's marketing database and to be used in accordance with the purposes set out in these Terms and Conditions, of which they may opt-out at any time.

## **ENTERING THE COMPETITION**

Multiple receipts over the promotional period are accepted. Receipt values must be equivalent to \$100 or more. Participants can enter multiple times as they reach \$100 in total spend. For each increment of \$100 spent, participants will earn an additional chance to spin the wheel. For example, if a participant spends \$300, they will have three chances to spin the wheel. All receipts must be uploaded for verification purposes.

# SPINNING WHEEL RULES AND REGULATIONS

One person per valid entry to spin the wheel at a time. Only one spin per valid entry allowed, and no re-spins allowed. If the indicator stops between the line of the two numbers, re-spin allowed. Participants spinning the wheel must be 18 years of age and above. Only one hand is permitted to spin the wheel and a round of full spin required before letting go of the hand. Not abiding by rules may result in disqualification from the competition.

## LIMITS ON ENTRY

There are no limits to entry if all conditions are met.

### **PRIZE DETAILS**

#### WINNER NOTIFICATION

Winners will be notified promptly of the result after spinning the wheel.

## **GENERAL**

Incomplete, indecipherable or illegible entries will be deemed invalid. If there is a dispute as to the identity of the entrant, the Promoter reserves the right, in its sole and absolute discretion, to determine the identity of the entrant. Redemption of the prizes for any goods or services are subject to the standard terms and conditions of the relevant providers. If for any reason a winner does not take the prize or an element of the prize at the time stipulated, then the prize or that element of the prize will be forfeited. ### **PRIVACY**
