

2024 WIN a \$5,000 Shopping Spree Promotion

Terms and Conditions

1. These terms and conditions apply to all entrants who enter the '2024 WIN a \$5,000 Shopping Spree Promotion'. Participation in this Promotion constitutes acceptance of these Terms and Conditions.
2. The "Promoter" is Casuarina Investment Fund Pty Ltd, ABN 28 815 802 041, 247 Trower Road, Casuarina NT 0810. Telephone number (08) 8920 2300. The shopping centre owners, managers, and all employees of all stores are ineligible to enter.

ELIGIBILITY

This Promotion is open to Casuarina Square customers residing in Australia who are 18 years of age and over. The following persons are ineligible for the Promotion: (i) directors and employees of the Promoter, its related companies or any of its agencies or retailers that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling of an aforementioned excluded person; and (iii) any person whom the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

The Promotion commences at 09:00am Australian Central Standard Time (ACST) on Monday, 30 September 2024 and closes at 05:00pm (ACST) on Saturday, 19 October 2024 ("Promotion Period").

HOW TO ENTER

To enter this Promotion, eligible individuals must:

1. Spend \$100 or more at Casuarina Square retailers, excluding major retailers (**Coles, Woolworths, Big W, Kmart, JB Hi-Fi and BCC Cinemas**), during the promotion period*. Multiple receipts over the promotion period are accepted. Receipt values must be equivalent to \$100 or more.
2. Fill in the **2024 \$5k Shopping Spree form** and upload your receipts. Must be the original store receipt. Copies and Eftpos terminal receipts are not accepted.
3. Each valid receipt submission counts as one entry into the draw. Multiple entries are allowed for each \$100 spent. There are no limits to entry as long as all conditions are met, and each receipt submission is valid.
4. A live draw will take place at Casuarina Square on Sunday, 20 October 2024, to determine the winner. The winner does not need to be present at the draw but will be notified directly by the Promoter after the draw.
5. Present your valid online entry form along with receipts to the Casuarina Square team member to claim the prize.

It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoter's marketing database and to be used in accordance with the purposes set out in these Terms and Conditions, of which they may opt-out at any time.

ENTERING THE COMPETITION

Multiple receipts over the promotional period are accepted. Receipt values must be equivalent to \$100 or more. Participants can enter multiple times as they reach \$100 in total spend. For each increment of \$100 spent, participants will earn an additional entry. For example, if a participant spends \$300, they can enter the promotion three times. All receipts must be uploaded for verification purposes. Participants have the opportunity to win a share of \$5,000 in Casuarina Square gift cards.

LIVE DRAW

A live draw will take place at Casuarina Square on Sunday, 20 October 2024, to determine the winner. The winner does not need to be present at the draw but will be notified directly by the Promoter after the draw.

LIMITS ON ENTRY

There are no limits to entry as long as all conditions are met, and each receipt submission is valid.

PRIZE DETAILS

The prize is a \$5,000 shopping spree, redeemable in Casuarina Square gift cards. The Promoter reserves the right to redraw in case of an invalid entry or invalid entrant.

WINNER NOTIFICATION

The winner will be notified by phone or email immediately following the draw.

GENERAL

Incomplete, indecipherable or illegible entries will be deemed invalid. If there is a dispute as to the identity of the entrant, the Promoter reserves the right, in its sole and absolute discretion, to determine the identity of the entrant. Redemption of the prizes for any goods or services are subject to the standard terms and conditions of the relevant providers. If for any reason a winner does not take the prize or an element of the prize at the time stipulated, then the prize or that element of the prize will be forfeited. PRIVACY
