

# TERMS & CONDITIONS Movie + Meal Deal 2021

## PROMOTION CENTRE: Casuarina Square

- 1) Information on how to enter and prizes form part of these terms and conditions. Entry into the Movie + Meal deal campaign (the Promotion) is deemed to be an acceptance of the following terms and conditions. Entries must comply with these conditions to be valid.
- 2) Who can enter? Entry is open to all participants. The Promoter's directors, management, employees, retailers, tenants of participating centres and their immediate families together with agencies and suppliers associated with this Promotion are ineligible to enter. Retailers may enter with a receipt from a different store to that of which they are currently employed at.
- 3) Promotion Period: This Promotion commences at 5pm on Tuesday, 1 September 2021 and closes at 12am on Tuesday 29 December 2021 or until tickets run out.
- 4) How to enter? To enter the Promotion, an entrant must, during the Promotion Period:
  - Purchase a meal to the value of \$25 or more per person from any restaurant located in The Quarter Casuarina Square. A meal consists of a food item listed on your chosen restaurant's menu, this does include drinks and sides.
  - Receipts can be combined to make the value of \$25, and can be at multiple participating stores.
  - You can only claim one movie ticket per person per Tuesday night and each person must be present to claim the movie ticket.
  - The purchase must be made after 5pm on a Tuesday at The Quarter to claim your free movie ticket
  - You must collect your free movie ticket on the same night as your purchase (from 5pm Tuesday)
  - Your receipt must be presented and stamped by the staff at BCC Cinemas Casuarina Square to receive your free movie ticket
  - Participating stores include: Sushi Bay, Hog's Breath Café, The Groove Train, PappaRich, Chatime, Baskin-Robbins, Crust Pizza, Nando's, Grill'd Healthy Burgers and The Coffee Club
- 5) How many times can you enter? Customers can submit one entry per person per Tuesday
- 6) Prize selections: Each customer can redeem one movie ticket per person, per \$25 spend at The Quarter per Tuesday.
- 7) Prize details: 1 movie tickets to any movie at Casuarina Square BCC Cinemas. The ticket is valid to use all day Sunday, Monday, Tuesday, Wednesday, Thursday, Friday, Saturday they are only valid before 5pm. They are not valid for public holidays, for special screenings or alternate content. There is a surcharge of \$4.00 the customer would have to pay if they wished to see a 3D film.
- 8) Total prize value: The total maximum total prize value is AUD \$11.50 per ticket. The value of each prize is accurate at the date of commencement of the Promotion and is based on the recommended retail price. The Promoter accepts no responsibility for any variation in the value of the prize(s).
- 9) Winners: The prize selection will be conducted at BCC Cinemas, Casuarina Square, 247 Trower Road, Casuarina, Northern Territory 0810 on each Tuesday after 5pm.
- 11) Disqualification: The Promoter reserves the right to verify the validity of any entry and to disqualify any entrant who forged, manipulated or tampered with the entry process, who submits an entry that is deemed inappropriate or is not in accordance with these terms and conditions or who does not provide all information requested on the entry form, where applicable.
- 12) Claiming prizes: Customers are to claim their ticket on the Tuesday evening, the same night of purchase of their meal. Tickets are to be claimed from BCC Cinemas. All prizes should be claimed and collected in person by the winner from the Centre at their own peril. Unless specified otherwise, it is the sole responsibility of winners to collect their prize. The Promoter will not notify winners of the time remaining. By claiming the prize and filling out the movie ticket form you are agreeing to sign up to the casuarina square database. You can opt out of this at any time.
- 13) Prizes: Prizes are not transferable or exchangeable and may not be redeemed for cash. All prizes are accepted entirely at the risk of the winner, and the Promoter excludes all warranties in connection with any prize to the extent permitted by law. The Promoter reserves the right to substitute any prize with a prize of equal or greater value (including where the prize is unavailable) for whatever reason, subject to approval of the gaming authorities in each State and Territory where required. The prize and/or any element of the prize must be taken as stated and cannot be varied by the winner. No compensation will be payable if the winner is unable to use their prize and/or any element of the prize as stated.
- 14) Redraw: Should the prizes remain unclaimed, there will be no redraw. The Promoter reserves the right to select a new winner in the event of an entrant being unable to satisfy these terms and conditions or not claiming a prize immediately.
- 15) Entries: No responsibility is accepted by the Promoter for late, lost, incomplete, incorrectly entered or misdirected entries or any social media profiles that are left on private setting. Any entry that is lodged by automatic, repetitive, robotic, programmed or similar entry methods or agents, including the use of a competition entry service (as determined in the absolute discretion of the Promoter) will be void.
- 16) Variation/cancellation: If for any reason this Promotion is not capable of running as planned, the Promoter reserves the right in its discretion to modify the terms of the Promotion including these terms and conditions and the prizes, subject to approval of the gaming authorities in each State and Territory where relevant.
- 17) GPT Gift Card Prize: Any prize which is or contains a GPT Gift Card is subject to the standard GPT Gift Card terms and conditions, available at [www.gpt.com.au](http://www.gpt.com.au).
- 18) Sponsored prize: Any prize which is sponsored by a retailer is subject to the terms and conditions of that retailer.
- 19) Liability and release: The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury, loss or damage suffered or sustained (even caused by negligence) in connection with accepting or using a prize or participating in this Promotion, except for any liability which cannot be excluded by law. The Promoter is not responsible for defective prizes, lost or stolen prizes or misuse of any prize. All entrants release from, and indemnify the Promoter against, all liability, cost, loss or expense arising out of acceptance of any prize(s) or participation in this Promotion including (but not limited to) personal injury and damage to property and whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise.
- 20) Printing errors: In the event of printing errors, quality control matters, structural faults or similar factors, any claims for prizes or entitlements to claims will be dealt with in accordance with the relevant state legislative requirements.
- 21) Entries property of the Promoter: All entries (including any information or drawings or items submitted with the entry) become the property of the Promoter. By entering this Promotion, each entrant consents to the entry being used by the Promoter (and the Promoter's Related Entities and agents) for any purpose whatsoever (including without limitation, in print and electronic format) and the Promoter may use, reproduce or modify the entry or any part of the entry without any further reference to the entrant (including not naming the entrant as the creator) or payment or other compensation to the entrant. Without limiting the foregoing the Promoter may use all or any part of the entry on the Promoter's website or in other forms of social media or on other websites or in any other media used by the Promoter for an indefinite period of time without attribution to the entrant.
- 22) Privacy: Each entrant's personal information may be collected, used and disclosed for administering this Promotion, complying with applicable laws relating to promotions such as this, passing on information to related entities, prize suppliers and relevant service providers and entering into a database for future promotional, research, marketing and publicity activities of the Promoter or its related entities.
